Sister of Charity Presence at the United Nations—from www.famvin.org

Sister Teresa Kotturan, SC Nazareth, will serve as the next NGO continuing the Federation's presence at the UN in its efforts to promote peace, justice and dignity for all throughout the world.

In 1997, the SC Federation hired Sister Marie Elena Dio, SC Halifax, as the first employee of the Federation to serve as an NGO Representative at the United Nations. Under her leadership, the Federation NGO was accredited with consultative status with the Economic and Social Council (ECOSOC) of the UN.

Each congregation of the Federation named a liaison to dialogue with Sister Marie Elena on priority issues. During her eight years at the UN, Sister Marie Elena was a founding member of Religious at the UN (RUN), a group to support efforts in promoting the principles of Catholic Social Teaching. She and Sister Faith Colligan, DC, were among the founding members of the Financing for Development NGO Committee in 2004 which came into existence to monitor the Monterrey Consensus to secure funding, trade agreements, and debt relief to assist developing countries in the implementation of the Millennium Development Goals of 2000. Sister Faith also served on the Committee for Social Development and for several years co-chaired

the Civil Society Forum which preceded the Commission for Social Development. Sister Janet McLaughlin, SC St. Elizabeth, served as an assistant for a number of years.

Sister Maria Goetschalckx, SC Seton Hill, served as NGO Representative for two years and brought her expertise to poverty and development issues as well as trafficking and migration. She continued the collaborative work with ECOSOC, other NGO Reps and multiple committees to apply the Vincentian charism and the Federation Strategic Plan to the development of political, economic, social and humanitarian policies of the UN.

In 2007, Sister Caroljean Willie, SC Cincinnati, assumed the role of NGO Representative. She continued the collaborative work with ECOSOC, other NGO Reps and multiple committees to apply the Vincentian charism and the Federation Strategic Plan to the development of political, economic, social and humanitarian policies of the UN. She engaged liaisons, members and Associates of the Federation congregations, the Vincentian Family, and students in the work of the UN. She educates on systemic change and the issues with presentations, newsletters, and issue alerts. Sister Cj



completes her second term in January 2015. Sister Faith also completes her service in 2015.

Sister Teresa Kotturan, SCN, has served in congregational leadership in the province of India and Nepal as well as on the Congregational Leadership Team based in KY. She collaborated as an NGO Liaison for five years and presented systemic change and UN issues to membership and their collaborators for implementation in their ministries. She brings vast international experience and studies to the role. She will begin an orientation with Sister Cj in October 2014.

Synthesis Report on Post-2015 Development Agenda

Secretary General Ban Ki-moon recently released a synthesis report entitled "The Road to Dignity by 2030: Ending Poverty, Transforming All Lives and Protecting the Planet". He noted that this report involved an unprecedented number of consultations including Member States, the UN System, experts, a cross-section of civil society, business and millions of people from all corners of the globe. He accepted the outcome document produced by the Open Working Group which listed 17 sustainable development goals and 169 targets. He stated that these goals are a "clear expression of the vision of the Member States and

their wish to have an agenda that can end poverty, achieve shared prosperity and peace, protect the planet and leave no one behind. The new agenda should include a compelling and principled narrative, based on human rights and human dignity. It will require serious commitments for financing and other means of implementation. And it should include strong, inclusive public mechanisms at all levels for reporting, monitoring progress, learning lessons, and ensuring shared responsibility."

The Rio+20 outcome document which mandated the creation of sustainable develop-

ment goals (SDGs) declared that the "SDGs should be action-oriented, concise and easy to communicate, limited in number, aspirational, global in nature and universally applicable to all countries while taking into account different national realities, capacities and levels of development and respecting national policies and priorities."

With that in mind, the Secretary General said that the synthesis report presented an integrated set of "Essential Elements".

Post-2015 Agenda cont'd

“The first element is dignity: an essential element for human development, encompassing the fight against poverty and inequality. Second is people: Millions of people especially women and children, remain excluded from full participation in society...Third, prosperity: We must develop a strong, inclusive and transformative global economy. Fourth, our planet: We have an urgent duty to address climate changes and protect our ecosystems for

ourselves and our children. Fifth, justice: to build safe and peaceful societies, and strong institutions. And finally, partnership: because this agenda will be built on a foundation of global cooperation and solidarity.”

The Economic and Social Council (ECOSOC) under the direction of its current President, Martin Sajdik of Austria, recently adopted a decision that set the theme of “Managing the transition from the

Millennium Development Goals (MDGs) to the SDGs: what will it take? for its 2015 session, and “Implementing the post-2015 development agenda: moving from commitments to results” for its 2016 agenda.

The NGO committees throughout the UN system are addressing the multiple aspects of the SDGs and the Post-2015 Development Agenda through the lenses of their members’ experience and expertise.

Updates

Congregations who have members in Democratic Republic of Congo, Haiti, India, Nigeria, Papua New Guinea, Philippines, and Sudan will be invited to submit information which will then be reviewed by UNICEF.
- Sister Teresa Kotturan is actively participating with Sister Faith Colligan in the multiple events pertaining to financing for development.
- The priority theme for the 2015 Commission for Social Development is "Rethinking and Strengthening Social Development in the Contemporary World."
- The main focus of the 2015 Commission on the Status of Women will be on the Beijing Declaration and Platform for Action, including current challenges that affect its implementation and the achievement of gender equality and the empowerment of women.
- The Sisters of Charity Federation is co-sponsoring two side events at the Commission on the Status of Women. The first is entitled "Unearthing Development: Extractivism and Women's Experience" and the second is entitled "Women's Leadership and Transformative Spirituality for a Just and Peaceful World."
- Sister Caroljean (Cj) Willie served as the Social Justice Chair at the Coady Institute at St. Francis Xavier University in Antigonish, Canada for several weeks during the fall. The Coady Institute is a learning organization dedicated to identifying, developing and disseminating knowledge on effective development practice. It is a leader in the study and practice of community-based development which provides relevant programs that help others make a positive difference in their own communities.
